It is therefore our obligation as a sphere of government to work towards a waste free environment in order to reach the goals and objectives adopted in the Polokwane Declaration National Waste Summit of September 2001 whereby each and every resident in every municipality will have to become a responsible manager of waste.

The following elements of an integrated waste management system could assist municipalities to effectively and promptly manage waste within their areas of jurisdiction:

- Waste Avoidance
- Minimize/ stop generation of waste
- Source Separation (Material Recovery and or Recycling)
- Temporary storage
- Collection
- Transportation
- Treatment/Processing
- Transfer

- Disposal
- Recycling

This competition is again aimed at encouraging the local municipalities as well as the residents / communities within Sisonke to play a very active role in the moral regeneration of their communities by restoring the pride and commitment in keeping our environment in a hygienic condition.

This competition is run within the district of Sisonke whereby an amount of R 250 000.00 prize money has been set aside. Notwithstanding the overall winners of the competition the Municipal will recognize the Local Municipality with the best of the following facilities.

Prices that will be awarded will be as follows:

- Best waste management
- Best Energy Efficiency and conservation
- Best Landscaping, tree planting and beautification
- Best Public participation and community empowerment
- Best Leadership and Institutional Arrangements

- How does the municipality monitor and control illegal dumping?
- If waste management complaints are laid to the municipality, how long does it take the municipality to react to the same? Is there a complaints register?
- State the municipality's anticipated future plans with regarding waste management.
- Indicate if you have ever received any award for the cleanest town competition. Was it a monetary award, if so how was it utilized?
