Harry Gwala District Municipality request written price quotations from the experienced, qualified and reputable service providers to assist the municipality with provision of the following items for Kilmon Rural Horse Riding Event to be held on the 19 November 2016

### **SPECIFICATION**

- Food preparation - 6M X 6M free standing white marquee, 4 steel/ trestle tables, and 5 white chairs.
- Payment marquee - 6M X 6m free standing white marquee, 2 trestle tables and 5 chairs.
- Venders marquee 3M X 40 M marquee with 50 chairs and 12 trestle tables
- Official's marquee -6M X 6M marquee with 5 tables with cloths and 20 covered chairs.

Engineer's stability certificates for the marquees must be provided  
Lightning conductor must be provided

Erecting of facilities must start on 15 November 2016 and completed no later than 16 November 2016.

### **Ablution Facilities**

- 4 VIP trolley Ablution facilities for female and males with flusher, hand washing basin and water, sanitizer, and toilet paper and personnel to clean toilets.
- 1 x disabled ablution facility with flusher, hand washing basin and water, sanitizer and toilet paper.
- 7 x mobile toilets facility with flusher, hand washing basin and water, sanitizer and toilet paper.

**Invalid or non-submission of the following documents will lead to immediate disqualification of the tender:**
