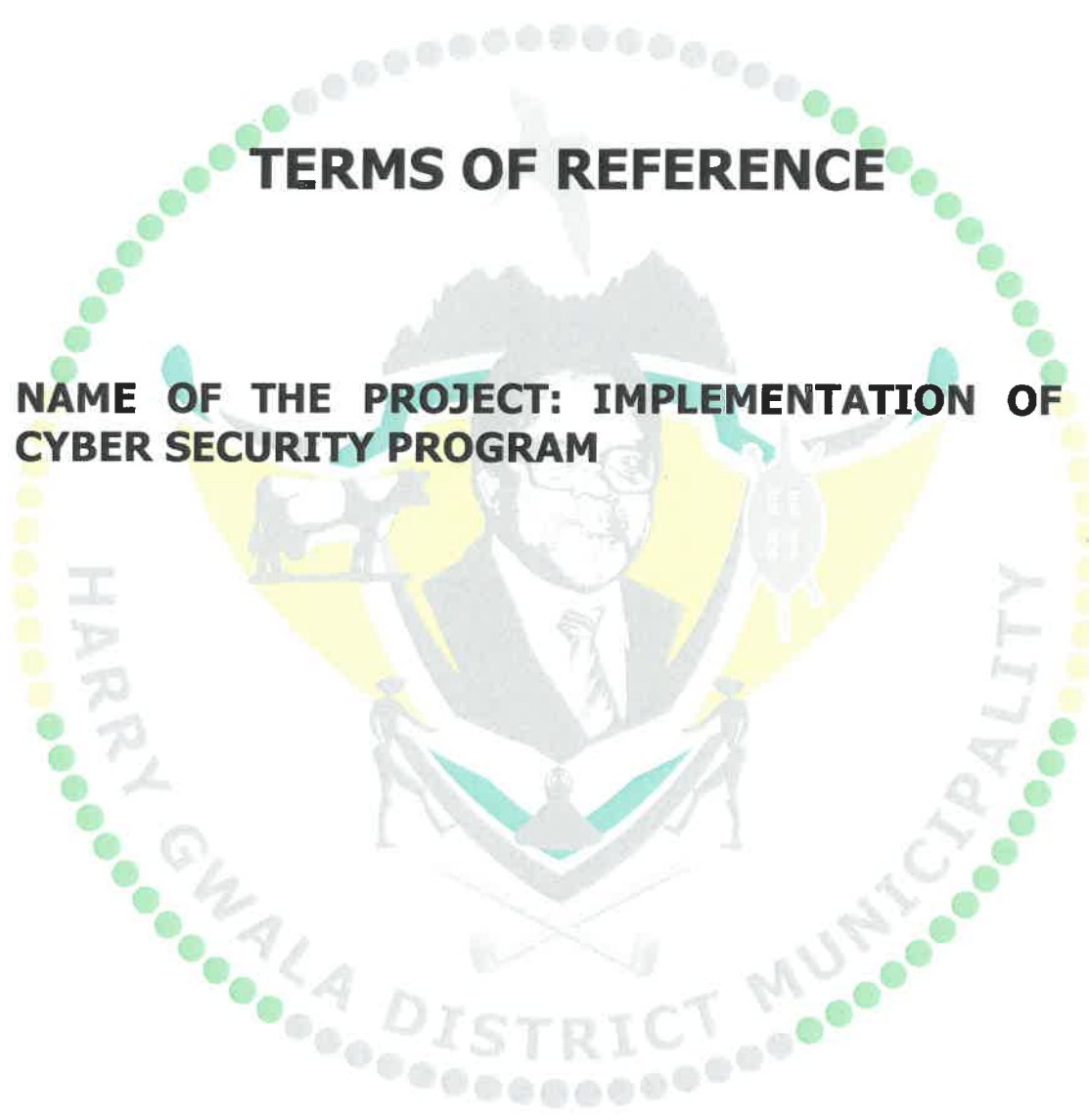

TERMS OF REFERENCE

**NAME OF THE PROJECT: IMPLEMENTATION OF ICT
CYBER SECURITY PROGRAM**

1. INTRODUCTION OF THE PROJECT

The municipality wants to appoint a service provider that is proactive to implement an ICT Cybersecurity Program that is capable to monitor and block threats, hackers 24/7 on Harry Gwala District Municipality (HGDM) systems.

The appointed service provider will be responsible to supply and maintain the system, the project is expected to be for a period of one year.

2. AIM OF THE PROJECT

The aim of the project is to ensure that cyber criminals are unable to bypass or breach the security measures in our system environment. Scanning vulnerability of network and firewall. Regular testing of firewall, website and e-mail for threats and maintenance.

3. SCOPE OF WORK

The service provider will be expected to plan, develop, implement and monitor a high-quality cybersecurity program i.e. detect threats, advanced protection, analysis threat intelligence, threat-detection capability platform.

4. KEY DELIVERABLES

- a) A project plan.
- b) Programme or application containing all features specified in the scope of work.
- c) Skills transfer to the ICT Unit.
- d) Skills transfer to the municipal employees.

6. CONDITIONS OF THE CONTRACT

A 1-year contract with a service level agreement signed with the appointed service provider to implement Cybersecurity Programme and maintain the system 24/7 to block threats and hackers from breaching our municipal systems.

7. PROJECT TIMEFRAME

The project must be complete within sixty (60) days. The cybersecurity programme must be period of one (1) year.

8. PROJECT BUDGET

- Service Providers must present a work plan and budget consistent with the amount of work as specified in the "scope of work".
- Service providers must present a proposal driven by cost saving methods and prices which are commensurate to the specified scope of work.
- The successful service provider shall be paid for services rendered on presentation of original tax invoice.

4. Bids submitted must be complete in all respects.
