TERMS OF REFERENCE

NAME OF THE PROJECT: PROVISION OF ICT PROFESSIONAL SERVICES, SUPPLY OF ICT EQUIPMENT AND SOFTWARE.

1. INTRODUCTION OF THE PROJECT

The Harry Gwala District Municipality utilizes Servers, Desktops, Laptops, tablets, software and other handheld devices to carry out it day-to-day operations. Example: drafting, printing of council agenda, sending and receiving of emails, storage of Municipal documents, processing of requisitions, orders and invoices, revenue collection, compiling annual reports, preparation of financial statements, recording of meetings, compilation of Harry Gwala District Municipality newsletter, etc.

Considering the above, the Municipality deemed it necessary to have current and up to date Servers, computer hardware and software readily available at all times as the number of computer users within the municipality continuously increasing. In addition, Harry Gwala District Municipality requires outsourced support for some of the ICT equipment and software used by the municipality on daily basis. The appointed Service Provider will be responsible for the Provision of ICT professional services and supply of ICT equipment and software. The contract will run over two years (24 months).




