### **WRITTEN PRICE QUOTATIONS EMERGENCY DECONTAMINATION OF MUNICIPAL OFFICES, BUILDINGS AND MUNICIPAL VEHICLES**

#### **REQUEST FOR FORMAL WRITTEN PRICE QUOTATIONS /PROPOSALS FOR EMERGENCY DECONTAMINATION OF ALL HARRY GWALA DISTRICT MUNICIPAL BUILDINGS AND MUNICIPAL VEHICLES (COVID-19 MEASURES) AS AND WHEN REQUIRED**

Proposals are hereby invited from reputable, suitable qualified and experienced service providers who will provide emergency decontamination of municipal of buildings and municipal vehicles for the period of 12 months contractual appointment for the financial year 2020/2021.

#### **SCOPE OF WORK**

The service Provider shall provide the following services as and when required:

- a) Disinfectant fogging services or
- b) The work shall be conducted within a 12- hour notice period and mainly after trading hours and when advised to minimize the disruption during office hours; or arrangements shall be made to close-off certain Departments/ Treatment Plants with the relevant authorities for decontamination during office hours.
- c) A suitable and approved chemical disinfectant in the form of a fine aerosol mist shall be applied that is effective in decontaminating the workspace from coronavirus and does not pose any harm to people when entering a workspace following decontamination (in line with the safe period permitted to enter a workspace).
- d) The use of diesel or petrol powered fogging machines is not permitted within buildings. The service provider shall use electrical or battery powered fogging machines for indoor disinfectant fogging.
- e) The fogging disinfectant must reach spaces that cannot be reached, ensuring that harmful germs are eliminated.
- f) The service provider shall submit a Safety, Health & Environment (SHE) File with the required documents to demonstrate compliance with the relevant Occupational Health & Safety; and Environmental regulations and also proof of using Thermal Fogging Treatment.

The following conditions will apply:

**Invalid or non-submission of the following documents will lead to immediate disqualification of the tender:**

- Valid tax clearance certificate or SARS pin.
- Central Supplier Database Registration.
- 5 reference letters proving similar work being done in the past 3 months (Proof of usage of Thermal Fogging Treatment Machines).

The following conditions will apply:

- Prices quoted must be firm.
- All quotations submitted shall be valid for 30 days after the closing date.
- A signed MBD4 form must be submitted with a price written quotation (available on our website and reception).
- A valid B-BBEE status level verification certificate must be submitted to claim preference points.
- 80/20 Preference points system will be used in evaluation.

**CLOSING DATE**

The closing date for the bidders is on 02 October 2020 at 12h00. Quotations must be enclosed in **SEALED ENVELOPES** and clearly labelled with the project name **"EMERGENCY DECONTAMINATION OF ALL MUNICIPAL BUILDINGS AND MUNICIPAL VEHICLES"** on the outside of the envelopes addressed to **The Municipal Manager**.
