- 4x black leather Executive high-back chairs with swivel tilt mechanism, padded arms back and seat, gas height adjustment, rubber support, chrome base.
- 60x black leather touch high-back chairs with swivel tilt mechanism, padded arms, back and seat, gas height adjustment.
